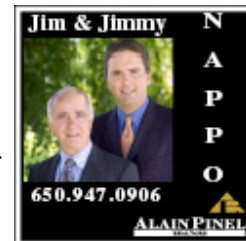

Stevens Creek Trail would harm habitat

Thank you for publishing Mr. Otto Sterba's letter (Town Crier, Jan. 30). I hope our paper can continue the dialogue to educate the residents of the south Los Altos area and those who travel through the area daily.

Stevens Creek in Los Altos is aligned with Sunnyvale on one side and Los Altos homes on the other side for the most part. The creek location in Los Altos and Sunnyvale compared to Mountain View is like night and day. From El Camino Real at Highway 85 (Mountain View), the Stevens Creek Trail to Shoreline Business Park is aligned with Highway 85, PG&E power poles and commercial properties all along the way.

That is not the case in Los Altos, unless you ruin the banks of the creek with asphalt trails and challenge the existing habitat of the land and waterways.

I'm all for safe trails through our city, but I believe we can do better by using the existing streets that can be improved upon and benefit those who choose to walk and bike through the area as I do daily.

The trail supporters want to route the trail from Mountain View High School to Rancho San Antonio Park. The existing streets of Grant Road and Foothill Expressway (Frontage Road) could be used.

The most people would benefit by these improvements with the least harm to the creek and risks to the security of the Los Altos homeowners for the least amount of money. Or does this make too much sense?

Creek trail an undeniable asset

The Town Crier recently published an opinion from Otto Sterba (Jan. 30) opposing a Stevens Creek Trail connector through Los Altos, citing potential crime, traffic congestion and a decrease in property values.

I'm dismayed by Mr. Sterba's largely misinformed viewpoint. Studies have repeatedly shown that recreational trails both lower crime (due to increased area vigilance by

trail users) and increase property values (due to recreational, health and environmental benefits of trail proximity). Further, facilitating a viable north-south bicycle route will lower congestion, especially given the forthcoming increase in traffic due to dense office developments under construction in the Moffett Field area. Finally, Mr. Sterba's suggestion that Los Altos has "enough parks and recreational areas" is a curious viewpoint, one that I doubt is shared by many of his fellow Los Altans.

Failure to establish an optimal connector between the Mountain View and Cupertino trail portions via available Los Altos public right-of-way would be a truly unfortunate missed opportunity.

While Mr. Sterba finds little appeal in the trail, to deny the larger community its undeniable benefits would be tragic. I urge the citizens and elected officials of Los Altos to enthusiastically support the extension of the Stevens Creek Trail through our city.

their fluorescent uniforms, pleaded with council members to renew the town's contract and continue a relationship going back 30 years.
